I have had the privilege and the pleasure of being a Trustee and the Chairman of Te Mana o Ngāti Rangithi Trust for the last 10 years.

Over that time we have achieved significant milestones the detail of which can be found on the Ngāti Rangitihi Website:

- Ngāti Rangitihi Settlement Act 2022
- Establishment of the Tarawera Awa Restoration Strategy Group
- · Development of a Strategic Plan,
- A Commercial Arm to manage our financial affairs,
- A Charitable Trust to recognise and provide support to whānau

We now have a fully operational Trust Office with talented staff working collaboratively with Trustees.

I am currently the Chairman of the Tarawera Restoration Strategy Group and member of the Ngāti Tarawhai, Tuhourangi, Ngāti Rangitihi lwi Consortium developing a tourist operation at Tarawera.

I am also responsible for leading the relationships with Central Government Ministers and Agencies, local Mayors and Council Staff, the Chairman and Staff of the BoP Regional Council and lwi leaders across the Motu, particularly in the Mataatua and Te Arawa rohe.

There is more to do and while I am one of the older Trustees currently on the Trust I believe I still have a lot to offer.

I bring extensive experience from my 35 years of involvement in the business of Ngāti Rangithi starting when I was the inaugural chair of Te Rununga o Ngāti Rangitihi and Ruawahia 28 Trust.

I remain committed to the aims and aspirations of our iwi. I seek your support to be appointed for a further three years.

I have also committed to establish education initiatives in Maori, by Maori, and for Maori in order that the next generations will be secure in our language, identity and culture.

I have been a trustee of Te Mana o Ngati Rangitihi since its inception in 2008. I am proud of the progress that has been made and I look forward to continuing to work for you and our future generations.

I am deeply committed to achieving cultural sovereignty, economic security, health and well-being for Ngati Rangitihi. Aroha nui naku (tamahine a Koro Dewes raua ko Kura Raureti).
