### 2019 Post-Settlement Governance Entity (PSGE) Ratification

#### DECLARATION OF RESULT

The final result of the PSGE ratification poll that closed at 5pm on Monday 8 July 2019 is:

##### **Resolution 1:**

*I, as a member of Ngāti Rangitahi, agree that the proposed new Te Mana o Ngāti Rangitahi Trust will be the Post-Settlement Governance Entity to receive and manage all of the historical Treaty of Waitangi settlement redress on behalf of Ngāti Rangitahi.*

**The majority (being 92.16%) of those voting on Resolution 1 voted YES/ĀE.**

**I therefore declare that Resolution 1 is ACCEPTED.**

##### **Resolution 2:**

*I, as a member of Ngāti Rangitahi, authorise the transfer of the mandate to negotiate the settlement of the Ngāti Rangitahi historical Treaty of Waitangi claims from the existing Te Mana o Ngāti Rangitahi Trust to the new Te Mana o Ngāti Rangitahi Trust.*

**The majority (being 92.47%) of those voting on Resolution 2 voted YES/ĀE.**

**I therefore declare that Resolution 2 is ACCEPTED.**

**Resolution 3:**

*I, as a member of Ngāti Rangitihī, agree that the initial trustees of the new Te Mana o Ngāti Rangitihī Trust will be the current trustees of the existing Te Mana o Ngāti Rangitihī Trust.*

NO/KAO	116	11.85
INFORMAL or BLANK VOTING PAPERS	9	

**The majority (being 88.15%) of those voting on Resolution 3 voted YES/ĀE.**

**I therefore declare that Resolution 3 is ACCEPTED.**

The voter return was 25.84%, being 988 votes received from 3,824 eligible voters, of which 41.40% voted by post or at a hui and 58.60% voted via the internet.
